*** Shipping to the ECU flash specialist is your responsibility, and is not included in the price of the flash. You will be provided with the flash service address after submission of this form. You will also be charged for return shipping from our ECU flash specialist to your home or installer. This shipping charge will meet the above indicated estimates if within the 48 contiguous United States. If shipped outside the 48 contiguous United States, shipping rates will be greater than those listed. Please contact us for a quote. The actual charge will be reflected in your order confirmation.**

Return and Refund Policy

Sector111 is committed to complete customer satisfaction with our products. We will accept returns for regularly-priced items within 30 days provided that the product has not been installed, has not been damaged in any way, and is in its complete and original packaging suitable for resale. A restocking fee of 15% will be charged for returned items that are not defective. We do not accept returns of custom ordered products. Costs of any free shipping included in the initial order will be deducted from the refund. To return a product, you must request a Return Merchandise Authorization number (RMA) prior to returning the product. Products without a valid RMA number will be refused from the shipper. An RMA may be requested by contacting customer service at 951-296-6762 ex 204. Once we issue a RMA, we must receive the product within 10 days or no refunds will be given. Shipping costs for returned items are your responsibility.

When returning any item, please be sure to pack the product properly. We recommend that you purchase shipping insurance. We cannot provide a refund for any product received in our warehouse in damaged condition. In such a case, you must file a claim with the shipping company and advise us as what to do with the damaged product. We will hold your product for 30 days, after which the product will be destroyed.

Damaged Goods

Any product that is received damaged must be reported within 24 hours of receipt. Sector111 cannot accept responsibility for any damages not reported within this timeframe. Upon receiving a product that is damaged, you must contact us for a Return Merchandise Authorization number before returning the product.

Cancelled Orders
